Latest Insights

The UK is set to see significant changes in National Insurance (NI) From April 2025. Employer NI contributions will rise from 13.8% to 15%, and the threshold for employer contributions will drop from £9,100 to £5,000 per year.

Kier Staffing Solutions is currently in conversation with Kier Group and will apply all necessary changes as and when required

Recent CSCS card changes are a result of the Building Safety Act and assessing competency of individuals against the CSCS cards they are applying for. Kier Staffing Solutions is working with Kier SHW on these changes

Grandfather Rights

- Candidates that previously held IA CSCS cards due to Grandfather Rights are no longer valid; workers will need to go through assessments to get the relevant competency-based skills card.
- Red Experienced Operator Cards are only allowed in exceptional cases during the transition.

Labourer/Skilled Workers

- Any skilled roles will require the relevant competency based CSCS card
- Labourers first applying for a green CSCS card will be issued a card for two years, and will be extended to 5 years upon renewal based on competency
- KSS are reviewing the worker population focusing on labourers, to ensure those with green cards are aware of the relevant awards and tests for renewal
